TERMS & CONDITIONS FOR TENDER NOTICE FOR COLLEGE CANTEEN – 2024-25

- The application form is available on college website i.e. <https://gcchamba.edu.in/> or can be had from the office of the Principal Govt. College Chamba with tender fees of 100/- (Rupee One hundred only) on all working days w.e.f. **13th September 2024 (Friday)** onwards.
- The duly filled application form along with all supportive documents i.e. Bank Draft / Experience etc. complete in all respect will be reached in this office only through **REGISTERED / SPEED POST / courier only** on or before **27th September 2024 (Friday)** by **01:00 PM** and superscripted as **CANTEEN-2024. BY HAND APPLICATIONS / TENDERS WILL NOT BE ACCEPTED IN ANY CASE.**
- Application forms / Tenders will be opened on the **27th September, 2024 at 03:00 P.M.** in the office of the Principal along with College Canteen Committee members.
- The application form must be accompanied with a banker draft for **25000/-** (Rupee twenty-five thousand only) drawn in favour of Principal Govt. College Chamba Himachal Pradesh for the deposit of earnest money/security.
- Minimum reserve price for bid is **Rs. 50000/-** (Rupee fifty thousand only).
- The right to receipt or reject any or all the tenders or part thereof, without assigning any reason is reserved with the Principal Govt. College Chamba.
- The Tenders may visit /examine the canteen and it's surrounding to assess the services before submitting their bid, no claim later on shall be entertained.

Terms and Conditions:

1. The Allottee to whom the canteen will be allotted shall have to deposit the **40%** bid price immediately within 3 days and rest in four equal quarterly instalments detailed as: - **First instalment** on **15th December 2024**, **2nd instalment** on **15th March 2025**, **3rd instalment** on **15th June 2025**, and **last instalment** on **31st September 2025**. Besides this, electricity charges have to be paid by the canteen holder.
 2. Every month canteen facility will be reviewed and if the canteen committee does not find it up to the mark, the contract will be rescinded without assigning any reason and amount deposited will be forfeited. Allottee shall have to supply all the articles throughout the year even in lean season.
 3. Canteen allottee shall have to take care of all the articles i.e. tables, chairs, mat, counter provided to him/them.
 4. Canteen allottee shall be responsible for cleaning of canteen and its surroundings.
 5. He may work between 08:30 AM. to 06:30 PM. in summer and till 5.30 PM. in winter.
 6. Principal Govt. College Chamba reserves the right of rejecting or discontinuing the contract without assigning any reason for breach of any of the provisions of the contract.
 7. Canteen Allottee shall have to maintain the quality of the food articles that can be inspected at any time.
 8. Canteen Allottee should not have been barred by any court to contract.
 9. The contract for the college canteen will be valid for the period of one year starting from the day of allotment.
 10. Smoking is strictly prohibited in the college canteen. Besides this the Allottee shall have to see that there is no drug abuse in the canteen. Incident of ragging if any should be brought to the notice of the Principal, Govt. College Chamba immediately.
 11. On allotment he shall have to start giving services within a week.
 12. The vendor can be asked to provide canteen services at old premises if need to be there.
 13. If allottee will withdraw to run the canteen he will be charged with additional 25% of bid amount.
